### **Group Therapy Note, Individualized - ICANotes**

Group Notes: This type of note is entered into an Encounter Note. All treatment group notes must be in DAP format. Information recorded must include a summary of what happened in group. The Group note is to be completed within the same business day as the group was held (or last group held in a work week for Residential/Halfway House group notes.)
